Dear Public Records Act Coordinator:

We are writing on behalf of **California Unions for Reliable Energy ("CURE")** to request a copy of any and all records related to the Torrey Wind Project ("Project"), proposed by Torrey Wind, LLC. This request includes, but is not limited to, any and all materials, correspondence, resolutions, memos, notes, analysis, electronic mail messages, files, maps, charts, and/or any other documents related to the Project.

The Project proposes to construct and operate approximately 30 new wind turbines (rated up to 4.2 megawatts each), an underground electrical collection system, a Project collector substation, a new 500 kilovolt substation/switchyard located adjacent to the Sunrise Powerlink, an operations and maintenance building, a temporary staging area, a batch plant, meteorological towers, and various access roads. The Project site is located on approximately 2,041 acres consisting of 13 parcels in southeastern portion of unincorporated San Diego County. The Project site is entirely on private land in the McCain Valley area, north of the community of Boulevard and Interstate 8 (I 8).

This request is made pursuant to the California Public Records Act. (Government Code §§ 6250, et seq.) This request is also made pursuant to Article I, section 3(b) of the California Constitution, which provides a Constitutional right of access to information concerning the conduct of government. Article I, section 3(b) provides that any statutory right to information shall be broadly construed to provide the greatest access to government information and further requires that any statute that limits the right of access to information shall be narrowly construed.

We will pay for any direct costs of duplication associated with filling this request up to \$200. However, please contact me at (650) 589 1660 with a cost estimate before copying/scanning the materials.
