We are writing on behalf of San Luis Obispo County Residents for Responsible Development to request *immediate access* to any and all public records referring or related to the City Boy Farms Project, Conditional Use Permit: DRC2017-00123 and Environmental Determination #19-043 ("Project") proposed by CB Farms ("Applicant"). Therefore, the ten-day response period applicable to a "request for a copy of records" under Section 6253(c) does not apply to this request.

We reserve the right to have a copy service make copies of any and all of the requested documents depending on the volume.
