We are writing on behalf of **San Joaquin County Residents for Responsible Development** ("San Joaquin Residents") to request *immediate access* to any and all records related to the Delicato Vineyards Project, Use Permit Application #PA-1700032 (UP), ("Project"), *since the date of our last request on March 29, 2017*, and any and all documents not previously released. The Project site is located on the west side of South State Route 99 West Frontage Road, 378 feet south of East French Camp Road, north of Manteca. This request includes, but is not limited to, any and all materials, correspondence, resolutions, memos, notes, notes of telephone

communications, analyses, electronic mail messages, files, maps, charts, and/or any other documents.

San Joaquin Residents is an unincorporated association of individuals and labor organizations that may be adversely affected by the potential impacts associated with Project development. San Joaquin Residents includes Plumbers & Pipefitters Local 442, International Brotherhood of Electrical Workers Local 595, and Sheet Metal Workers Local 104, and their members and their families who live and/or work in San Joaquin County. San Joaquin Residents have a strong interest in enforcing the State's environmental laws that encourage sustainable development and ensure a safe working environment for its members.

We request immediate access to the above records pursuant to section 6253(a) of the Government Code, commonly known as the California Public Records Act ("PRA")<sup>1</sup>. This request is also made pursuant to Article I, section 3(b) of the California Constitution, which provides a Constitutional right of access to information concerning the conduct of government. Article I, section 3(b) provides that any statutory right to information shall be broadly construed to provide the greatest access to government information and further requires that any statute that limits the right of access to information shall be narrowly construed.
