#### Dear Mr. Rausch:

CREED LA is writing to request a copy of any and all records related to the following projects:

- 1045 South Olive Street. (City Case No. VTT-74531-CN and CEQA No. ENV-2016-4630-EIR). The developer is proposing a 714-foot tall building, featuring 800 condominiums above ground-floor retail space and amenities.
- 100 South Broadway. (City Case No. VTT-74761). The developer is proposing 53 and 37-story mixed use towers with 1,127-units & 34,000 sf of ground-floor commercial space and adaptive reuse of existing LA Times building into office space.
- 1101 East 5th Street. (City Case No. CPC-2016-4475-GPA-VZC-MCUP- CUX-DB-SPR; VTT-74703-CN, and CEQA No ENV-2016-4476-EIR). The developer is proposing a 12-story building featuring multifamily residential units, retail space, and a hotel. There will be 129 live-work condominiums, a 113-room boutique "art" hotel, and 70,000 sf of ground-floor shops and restaurants.

We are also writing to request copies of all communications and mailed notice of any and all hearings and/or actions related to the Project.

Our request for mailed notice of all hearings includes hearings, study sessions and community meetings related to the Project, certification of the MND (or recirculated DEIR), and approval of any Project entitlements. This request is made pursuant to Public Resources Code Sections 21092.2, 21080.4, 21083.9, 21092, 21108 and 21152 and Government Code Section 65092, which require local agencies to mail such notices to any person who has filed a written request for them with the clerk of the agency's governing body. Our request includes notice to

Our request for all records related to the Project is made pursuant to the California Public Records Act. (Government Code § 6250 et seq.) This request is also made pursuant to Article I, section 3(b) of the California Constitution, which provides a constitutional right of access to information concerning the conduct of government. Article I, section 3(b) provides that any statutory right to information shall be broadly construed to provide the greatest access to government information and further requires that any statute that limits the right of access to information shall be narrowly construed.

We will pay for any direct costs of duplication associated with filling this request up to \$200\_. However, please contact me at (877) 810-7473 with a cost estimate before copying/scanning the materials.
