We are writing on behalf of Coalition for Responsible Equitable Economic Development ("CREED LA") to request *immediate access* to any and all documents referenced or relied upon in the Draft Environmental Impact Report ("DEIR") prepared for the 5th and Hill Project (ENV-2016-3766-EIR; VTT-74659; VTT-74593; CPC-2016-3765-TDR-MCUP-CUX-ZV-MSC-SPR) (SCH No. 2017031018) ("Project"), proposed by JMF Enterprises V, LLC. This request excludes any documents that are otherwise available on the City of Los Angeles website.<sup>1</sup>
