We are writing on behalf of California Unions for Reliable Energy ("CURE") to request a copy of any and all records and communications generated or received by the California Public Utilities Commission ("CPUC") related to the California American Water Company's Monterey Peninsula Water Supply Project (SCH No. 2006101004) ("Project") *since the date of our last request on December 15, 2016.*

This request includes, but is not limited to, any and all materials, correspondence, resolutions, memos, notes, analysis, electronic mail messages, files, maps, charts, and/or any other documents related to the Project. This request *excludes*:

- submissions from parties' to the following CPUC proceeding: *In the Matter of the Application of California American Water Company (U 210 W) for Approval of the Monterey Peninsula Water Supply Project and Authorization to Recover All Present and Future Costs in Rates (A.12 04 019).*
- the Project's Draft Environmental Impact Report/ Environmental Impact Statement, public comments, and other records available at <http://www.cpuc.ca.gov/Environment/info/esa/mpwsp/index.html>.

This request is made pursuant to the California Public Records Act. (Government Code §§ 6250, et seq.) This request is also made pursuant to Article I, section 3(b) of the California Constitution, which provides a Constitutional right of access to information concerning the conduct of government. Article I, section 3(b) provides that any statutory right to information shall be broadly construed to provide the greatest access to government information and further requires that any statute that limits the right of access to information shall be narrowly construed.
