Dear Public Records Act Coordinator:

We are writing on behalf of California Unions for Reliable Energy ("CURE") to request a copy of any and all records related to proposed upgrades to the existing 115 kilovolt (kV) Pacific Gas & Electric (PG&E) Bridgeville Substation. The Bridgeville Substation is located at 26380 State Route (SR) 36 on a 1.0 acre parcel (Assessor Parcel Number 207 311 002 000) within the unincorporated community of Bridgeville in Humboldt County, California. This request includes, but is not limited to, any and all materials, correspondence, resolutions, memos, notes, analysis, electronic mail messages, files, maps, charts, and/or any other documents related to proposed upgrades to the existing Bridgeville Substation.

This request is made pursuant to the California Public Records Act. (Government Code §§ 6250, et seq.) This request is also made pursuant to Article I, section 3(b) of the California Constitution, which provides a Constitutional right of access to information concerning the conduct of government. Article I, section 3(b) provides that any statutory right to information shall be broadly construed to provide the greatest access to government information and further requires that any statute that limits the right of access to information shall be narrowly construed.
