**Re: Public Records Act Request CalAm Monterey Peninsula Water Supply Project (Appeal Number A 3 MRA 19 0034)**

Dear Public Records Act Coordinator:

We are writing on behalf of **California Unions for Reliable Energy ("CURE")** to request a copy of any and all records related to the CalAm Monterey Peninsula Water Supply Project ("Project"), *since the date of our last request on November 21, 2019*. This request includes, but is not limited to, any and all materials, applications, correspondence, resolutions, memos, notes, analysis, electronic mail messages, files, maps, charts, and/or any other documents related to the Project. This request also includes any and all materials related to Appeal Number A 3 MRA 19 0034.

The California American Water Company ("Cal Am") proposes to develop water supplies for Cal Am's Monterey District service area (Monterey District), including a subsurface source water intake system; a desalination plant; a brine discharge system; product water conveyance pipelines, one pump station, storage facilities; and improvements to the existing Seaside Groundwater Basin's aquifer storage and recovery system.

This request is made pursuant to the California Public Records Act. (Government Code §§ 6250, et seq.) This request is also made pursuant to Article I, section 3(b) of the California Constitution, which provides a Constitutional right of access to information concerning the conduct of government. Article I, section 3(b) provides that any statutory right to information shall be broadly construed to provide the greatest access to government information and further requires that any statute that limits the right of access to information shall be narrowly construed.
