

We are writing on behalf of Napa/Solano County Residents for Responsible Development ("Napa/Solano County Residents") to request access to any and all public records referring or related to the Commerce 217 Distribution Center Project, SCH Number 2020120302, Application PL20-0008, ("Project"), proposed by SDG Commerce 330 LLC ("Applicant") since the date of our last request, April 15, 2021.

The Project proposes to develop a 217,294 square-foot wine distribution center on a 10.39-acre parcel located at 1075 Commerce Court in the Recreation zoning district in the City of American Canyon, Napa County (Accessor's Parcel

Number 058-030-065). The Project would also include parking spaces, trucking docks, landscaping, a 21,000 square-foot bio retention pond, and approximately 4,350 square-feet of office space.

Napa/Solano County Residents includes the International Brotherhood of Electrical Workers Local 180, Plumbers & Steamfitters Local343, Sprinkler Fitters Local 483, International Association of Sheet Metal, Air, Rail and Transportation Workers Local 104 (SMART), and the District Council of Ironworkers, as well as other individuals that live and/or work in American Canyon and Napa and Solano Counties.

This request includes, but is not limited to, any and all materials, applications, correspondence, resolutions, memos, notes, analyses, electronic mail messages, files, maps, charts, and/or any other documents related to the Project.

This request is made pursuant to the California Public Records Act (Government Code §§ 6250, et seq.). This request is also made pursuant to Article I, section 3(b) of the California Constitution, which provides a Constitutional right of access to information concerning the conduct of government. Article I, section 3(b) provides that any statutory right to information shall be broadly construed to provide the greatest access to government information and further requires that any statute that limits the right of access to information shall be narrowly construed.
